ORDER:

In the reference 2nd read above, Government have issued orders extending UGC revised pay scales, 2016 to the eligible teaching faculty of all Government Medical and Dental Colleges in the state on par with teaching staff in Universities and Colleges in terms of orders issued vide G.O. 1st read above, with effect from 01.01.2016. It was further ordered that they shall be paid in cash from the month of September 2020, payable in October 2020. Orders as regards payment of the arrears of salary from 01.01.2016 to 31.08.2020 would be issued separately.

2. In the reference 3rd read above, Government have communicated the Pay Matrix in the UGC revised pay scales, 2016.

3. In the reference 4th read above, Director of Medical Education, Telangana, Hyderabad has furnished proposals for payment of UGC 2016 scale arrears from 01.01.2016 to 31.08.2020 to teaching faculty in Government Medical / Dental Colleges and teaching hospitals in state and requested issue orders.

4. Government after examination of the proposal, hereby order payment of arrears from 01.01.2016 to 31.08.2020 to in service and retired teaching staff drawing UGC scales, 2016 under the administrative control of Director of Medical Education, Telangana, Hyderabad, subject to the following:-

- a) In respect of employees with GPF, arrears payable for the period from 01.01.2016 to 31.08.2020 shall be credited into the GPF account with a lock in period of three (03) years.
- b) In respect of employees who were appointed into Government service on or after 01.09.2004 and are governed by the Contributory Pension Scheme (CPS), 10% of the arrears payable for the period from 01.01.2016 to 31.08.2020 shall be claimed and credited to the PRAN accounts of the individuals along with the Government share of Rs.19.32 Cr. as per existing orders. The remaining 90% of arrears shall be paid in (36) installments.
- c) In respect of employees eligible for UGC scales, 2016 and retired between 01.01.2016 to 31.08.2020, under GPF scheme, the arrears shall be paid in (36) equal monthly installments.
- d) In respect of employees eligible for UGC scales, 2016 and retired in between 01.01.2016 to 31.08.2020, under CPS scheme, the arrears shall be paid in (36) equal monthly installments.
- e) In respect of the employees / pensioners who were eligible for UGC Scales, 2016 and expired on or after 01.01.2016, their family/ legal heirs shall be eligible for lumpsum amount payable.
