ORDER:

In the G.O. 1st read above, orders were issued extending U.G.C. Revised Pay Scales, 2006 to University and College Teachers with effect from 01.01.2006 in the State.

2. In the G.O. 2nd read above, orders have been issued extending the U.G.C Revised Pay Scales 2006 to Teaching Faculty of Government Medical and Dental Colleges in the State with effect from 01-11-2006.

3. In the reference 3rd read above, Government of India have revised the UGC scales for University and College Teachers with effect from 01.01.2016, and decided to extend the scheme to Universities, College and other Higher Educational institutions coming under the purview of State Legislatures, provided State Governments wish to adopt and implement the scheme subject to terms and conditions.

4. In the reference 5th read above, the Director of Medical Education, Telangana, Hyderabad has informed that the Higher Education Department vide G.O. 4th read above, have adopted the U.G.C Revised Pay Scales- 2016, and extended the same to the University and College Teachers in the State, w.e.f. 01.01.2016 and he has proposed for adopting and extending the U.G.C Revised Pay Scales 2016 to the teaching faculty of Government Medical and Dental Colleges as per the orders issued in the reference 4th read above.

5. Government, after careful examination, hereby order extension of the U.G.C Revised Pay Scales, 2016 to the eligible teaching faculty of all Government Medical and Dental Colleges in the State on par with teaching staff in Universities and Colleges in terms of orders issued vide G.O. 4th read above w.e.f., 01.01.2016. The Institution wise posts covered for extension of U.G.C. Revised Pay Scales, 2016 are appended to this order as Annexure-I.

6. The fixation of pay and allowances in the revised U.G.C Pay Scales, 2016 shall be strictly as per U.G.C/ Government of India orders/ guidelines as agreed and approved by the State Government for Higher Education Department in the G.O. 4th read above.
7. Salaries in the revised U.G.C Pay Scales of 2016 will be paid in cash from the month of September 2020, payable in October 2020. Orders as regards payment of the arrears of salary in the U.G.C Revised Pay Scales, 2016 from 01.01.2016 to 31.08.2020, would be issued separately.
8. The anomalies, if any, in implementation of U.G.C Revised Pay Scales, 2016, shall be brought to the notice of the Government for clarification.
9. Any pay fixations contrary to the above orders are liable for revision of pay and the excess amount paid thereon shall be recovered from the salaries of the concerned employees without any notice.
10. The Director of Medical Education, Telangana, Hyderabad shall take necessary action accordingly.

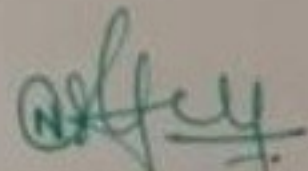

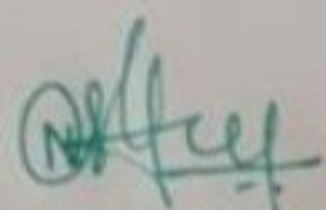
